### BOCCIA

The design and manufacture of a better ball release mechanism is the next challenge for Russell Maxwell ([MaxwellPro](#)) as the hard plastic suction tubing wrapped in a face washer and bound with surgical tape to his foot (pictured) just isn't cutting it any more. Russell is configuring a device that is easy to connect and will help Samuel keep a consistency of ball release to help his game improve.



### HOUSE MODIFICATIONS



Front yard landscaping has been the focus during the last few months. Fence posts are up and the retaining wall to maximise level ground area is all but finished. We will need to pave and concrete some areas to allow for pedestrian access from the footpath and have the fence panels installed. We should be ready then to introduce a canine to Samuel's world.
