
We are gearing up for our first plan review. This involves consulting with medical and allied health professionals to consider what will be needed for the next twelve months. The planning/application writing is still a work in progress for the upgrade of the area at the back of the house with a permanent ramp for accessing this area. New vehicle modifications are also required for the new car we need to purchase. Why would we need a new car? Read on!

### **HEALTH**

Samuel was under general anaesthetic for nearly seven hours on the twelfth of last month undergoing corrective spinal surgery. From a combination of factors, scoliosis was always threatening to be an issue and earlier this year it had deteriorated to the point that action needed to be taken. The surgery

involved a new technique where titanium rods are hooked into the pelvis and thoracic vertebrae rather than being fused along the length of the spine.

Samuel endured severe pain controlled with considerable pain management medications and the results have been very impressive with him looking and feeling much straighter. And taller. Hence the



new car. Samuel's arm rests have been lifted by at least 6cm and if he drives



in to the car as he used to, he now hits his mid forehead on the top of the back entry. Samuel needs to tilt his chair significantly to enter and travel in the car which limits visibility for him and is ultimately not sustainable.

Recovery also included some serious iPad and "Maggie" time in bed!
